 - **Technical Information:** Website usage data such as IP addresses, browser type, and cookies (used only for site functionality and analytics).

- **Title 17 Regulations (Client Rights).**

Your information will only be shared:

- With your written consent (or that of your authorized representative).
- For treatment, payment, and operations as allowed by HIPAA.
- When required by law (e.g., mandated abuse reporting under WIC §15630).
- In emergencies to protect your safety or the safety of others.

5. Mobile Information Privacy

- **No mobile information will be shared with third parties/affiliates for marketing or promotional purposes.**
- All other categories exclude text messaging originator opt-in data and consent.
- **Text messaging originator opt-in data and consent will not be shared with any third parties.**
